INAGRUAL BBQ CHAMPIONSHIP COOK-OFF**

Official Rules

1. WinStar World Casino is a governmental enterprise of The Chickasaw Nation, ("Nation") a federally recognized sovereign Indian tribe. WinStar World Casino is giving away a total of 18 Horizon Smokers valued at \$31,282.00, plus \$5,000 cash for a total of \$36,282 in Cash and Prizes on Saturday, May 21, 2011.
2. Patrons must be eighteen (18) years of age or older with a valid photo I.D. to participate. Employees of WinStar World Casino and/or any promotional sponsors and anyone who is barred or banned from any of the Nation's gaming facilities are not eligible to participate or win.
3. Registration will be \$150 per team.
4. The Lone Star Barbecue Society, as the sanctioning organization for this event, will be solely responsible for determining all cook-off rules definitions and judging for the awarding of Cash and Prizes.

*All cooks will be given a copy of the LSBS "Cooks Tips" leaflet when they check in at the site, together with a sheet containing turn-in times and rules. Copies of these items are included a pocket. The following LSBS Rules are to be followed for Nation's cookoff to be sanctioned by **the Lone Star Barbecue Society** and doing so entitles Nation to the use of our name and logo in any advertising.*

COOKOFF RULES & DEFINITIONS
*RULES***

COOKED ON SITE - All meat *will be* brought to the cooking site RAW! No pre-marinating, presoaking or pre-spicing prior to Official START time Friday. Meat WILL be inspected and will be prepared from scratch within the time constraints Of the cookoff. *NO meat will be allowed to leave site after it has been inspected.*

• OFFICIAL "START" TIME – After all your meat has been inspected. The cooks may begin to spice their meats at this time. Nothing is to be done prior to this time.

• TURN IN TIMES - Turn-in times shall be posted on site and announced in the cooks meeting. Head Judge will determine the times with the promoter. Standard times are 11:00 a.m., 12:00 p.m. 1:00 p.m., & 2:00 p.m. If there are a large number of cooks, 50 plus, turn-in times will be expanded to hour and a half increments or two hour increments. Special circumstances (additional categories) may dictate different time variables. Official time is that kept by the judging coordinator.

• **TURN IN QUANTITIES** - Head Cook's will turn in nine(9) full slices of Brisket, 1/4 to 3/8 inch thick (approximately the size of a pencil); If meat is sliced too thick the cook will be asked to return and put a different slice to replace the thick slice. Cook will turn in nine (9) full **pork spare ribs**;

Chicken will be one-half of a whole chicken *not disjointed* containing a breast **portion, leg, thigh, wing & skin. Note: Lid must close securely on turn-in tray. Very** large cookoffs may require the cook to turn in two (2) halves. Other types of meat will be addressed at cooks meeting.

• **MARKERS AND GARNISH** - Cooks may cook with sauce, however when preparing meat products for turn-in, nothing may be added to the meat after it is prepared for turn-in. Head Cook will *be* asked to correct their turn-in if sauce or juice is added to the meat. Nothing should be "puddled" in the tray. Any and all darnishes are prohibited_ Sauce should be cooked ON the meat

• **SANITARY CONDITIONS** - The Head Judge may disqualify a contestant for unsanitary conditions or entries. Cooking pits must be clean to the judges satisfaction..

• **WOOD FIRE** - Fires for cooking meat must be wood or wood products (charcoal) or wood pellets. Gas lighters, electric blowers and/or rotisseries only are permitted. **NO gas or electric cooking heat.**

Cooking teams must be registered by 12:00 a.m., Saturday, May 21, 2011, to be eligible for cash and prizes.

1. The "WinStar World Casino 2011 Inaugural Championship BBQ Cook-Off" will have four (4) categories; Chicken, Pork Butt, Ribs and Brisket.

2. Each of the four (4) categories will pay nine (9) places in cash and prizes. The payout for each category is as follows: 1st Place - Horizon 20” RD Special Marshal Smoker \$1725.00, 2nd Place - Horizon 20” Classic Smoker \$995.00, 3rd Place – Horizon 16” Classic Smoker \$789.00, 4TH Place – Horizon 16” Patriot Grill \$469.00, 5th Place - \$250.00 cash, 6th Place - \$200.00 cash, 7th Place - \$175.00 cash, 8th Place - \$150.00 cash, 9th Place - \$100.00 cash.
3. The Grand Champion will receive a Horizon 30” Triple Door Trailer Smoker valued at \$9,085.00 plus \$1,000 guaranteed cash. The Reserve Champion will receive a Horizon 24” Double Door Trailer smoker valued at \$6,285.00 plus guaranteed \$500 cash.
 - a.) Patrons must be present to win.
 - b.) WinStar World Casino 2011 Inaugural BBQ Championship judges will be the sole determinate of each winner.
4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes will be released.
6. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
9. Participation in this giveaway further constitutes the affirmative consent of each entrant to the courts and laws of the Chickasaw Nation, which shall govern this giveaway.
