4. All meat and beans subject to inspection. NO PRE-COOKED OR PRE-SEASONED MEAT, NO DUG PITS.
5. Contest meats are not to be sampled by the general public or judges prior to judging.
6. ALL ALCOHOLIC BEVERAGES MUST BE CONFINED TO THE COOK-OFF AREA. The Chief Cook will be responsible for the cleanliness of their area and for the conduct of the team. Misconduct or violations of rules will disqualify team.
7. ELECTRICAL HOOKUPS \$20.00 (LIMIT ONE) First come – First served. 8 – 10 electrical hook ups available at this time – hope to have more.
