- Contestants and Judges must be at least 21 years of age.
- Contest limited to the first 20 entries (20 Marys and 20 Margs). No late entries will be accepted.
- Recipes must be original and tomato/lime based.
- The use of mixers is allowed.
- **VODKA/TEQUILA** shall be the only permitted alcohol ingredient.
- Contestants will provide the alcohol, if desired. Virgin Mary's/Margs are allowed.
- Contestants must bring a minimum of **48 ounces** of prepared recipe in a sealed container accompanied by a completed presentation glass with garnish.
- Entry may be placed in any container; however, no distinguishable marked containers will be permitted with the name of the team or team logo.
- Contest coordinator will provide for the Judges: drink ware, ice and straws.

LAGT Cook Off is right around the corner and it is time to apply for a booth! This is our first year to have this event and we are hoping it becomes a yearly thing, that grows each year. This event will help to put funds into our scholarship fund for the local Seniors of Lampasas and Lometa High School. We really appreciate your participation in this event and we wish you a busy and profitable weekend!

This year 2019, Vendor will be allowed to start moving in and setting up on Friday, October 4, 2019 at 8am. Booths will need to open for sale of your product on Saturday, October 5, 2019 at 8:00am until the end of the cookoff, Friday Sales are up to the seller, we will be using Friday for set up and move in for all the cookers and vendors. WE however will be promoting that Vendors will be available on Friday afternoon as well as all day on Saturday.

Check in must be done upon arrival on the grounds before unpacking. There will be a tent set up when you drive in to check in at. This is also where you will get directions to your booth.

LAGT Cook off is an outdoor. Booths are *approximately* 10'x10' for \$75.00. Additional power may be secured for \$35 extra. This power must be applied for in your application. The Festival grounds are grassy unless we are blessed with rain. You may bring a floor covering to cut down on dust.

You must manage your own booth and bring your own equipment such as tables, chairs, fans. You will need a sun shelter as there will not be much shade. Also, we can usually accommodate in advance 2 people who want to be adjacent to each other but need separate applications. We will put out a local advertisement of all vendors before LAGT Cookoff. Please bring a curtain/cover for the front of your booth for Friday night.

LAGT Cook Off Exhibitors 2019 Rules and Regulation

1. Application fee must be received with completed application. Make checks payable to LAGT Postdated checks will not be accepted. Vendors will be emailed to notify receipt of application and of incomplete application. September 1, 2019 is the deadline to pay for your booth, after this date add \$25.00 to each 10x10 booth fee. There will be no Holds after August 15, 2019.
2. Once your application is confirmed a letter of acceptance or no acceptance will be mailed to you by August 31, 2019. The Lampasas Area Go Texan Committee reserves the right to disapprove any application.
3. Booth spaces will be \$75.00 for an approximate 10' x 10' space. Double spaces will be \$150.00. All spaces are outside. September 1, 2019 is the deadline for these fees, after that add \$25.00.
4. Power may be secured for an additional \$35 per space. This additional power must be applied for in your application. Exhibitors will not be allowed to exceed the power consumption applied for in your application.
5. No refunds or cancellations will be accepted after August 31, 2019.
6. Each exhibitor will check in with Rusti upon arrival and before unloading on the event grounds and shown to your space. Please bring your acceptance letter.
7. Exhibitors may set up starting Fri Oct 4, 2019 at 8 am. If you choose not to sell on Friday night you may unload and set up Saturday beginning at 6:00am until 8:00am. Your vehicle will need to be moved from the vendor area no later than 8:00am.
8. Each exhibitor will be expected to display with in your own space. Only one exhibitor is allowed per booth. If you desire a different set up, you must request that on your application and it must have special approval. Please bring a curtain/cover for the front of your booth for closing time.
9. Exhibitor will be responsible for managing their own booth, keeping it open for sales during exhibit hours and not closing or leaving early. You may bring tables, chairs, fans etc. but they must stay within your booth space. LAGT does NOT allow nudes or distasteful material to be exhibited or sold at this event. Each exhibitor is asked to keep your area free of trash.
10. As a LAGT Cook off exhibitor, you are authorizing LAGT to use your name as well as any photos taken for advertising purposes related to LAGT Cook off.
11. **LOAD-OUT or PACK-OUT.** Please do not start moving your booths out until the cook off is officially over, that would be after the judging has been announced. You can start packing up while the judging is being announced, but we would prefer you not pull your vehicles into the vendor area until the cook off is completely over.
