Rules & Regulations

1. LSBS will provide head judge. *All contestants must comply with LSBS rules.* <http://www.lonestarbarbecue.com>
2. **Contestants must check in at Cook-Off Headquarters on Courthouse Lawn**
3. Contestant to furnish meats, pit, wood, sauce, etc. ONLY BEANS MAY BE COOKED ON GAS OR ELECTRIC.
4. All meat will be inspected upon arrival. Beans subject to inspection.
5. No pre-cooked or pre-seasoned meat. No dug pits. Cook fires fueled by other than natural wood, charcoal, or commercial prepared charcoal will not be permitted.
6. No sampling of contest meats by the general public or judges prior to judging.
7. **All food and alcohol beverages from the cook-off area must remain in COOK-OFF AREA.**
8. Each cook will be responsible for the cleanliness of their area & for the conduct of the team. **Misconduct or violations of rules will be subject to disqualifications.**
9. Parking should be in a mannerly fashion in the parking lot. NO PARKING AROUND JOHNSON FEED
10. **NOTICE: Only contestant vehicles will be allowed -- PARKING WILL BE ENFORCED!**
11. Official Start Time is after meat is inspected. Rain or shine – **No Refunds.**
12. Turn in times and other cook-off details will be announced at **cook's meeting.**
13. Check in time at Coleman Courthouse – Friday, Oct. 4th from 5 PM – 9 PM Out of town contestants who need extra travel time, please make arrangements with the Chamber **48 hrs. in advance.**
14. Law Enforcement Security will be enforced. **All Visitors will leave at this time.**
